To vote for a person whose name is NOT printed on the ballot, write the person's name on the blank line in the appropriate block and mark a cross (X) in the square to the right.

To vote FOR an article, mark a cross (X) in the square at the right of YES. To vote AGAINST an article, mark a cross (X) in the square at the right of NO.
